Who Should Apply?

Industry leaders (across segments): Large enterprises, SMEs & start-ups

NGOs & Not for profit: delivering practical and scalable circular solutions.

National & International organizations/ institutions including laboratories & research institutes



Eligibility Criteria & Guidelines

The challenge is open to entities legally registered within India or abroad doing remarkable work in the environment and sustainability space.



Initiatives / projects that are implemented during the last 4 years i.e. Jan 2021 to Nov 2025 will be eligible for nomination.



Applicants must provide supporting documents for their assessment. Assessors may request additional documents, which should be shared promptly to avoid disqualification.



The Jury/ assessors hold the right to disqualify any application which does not meet the eligibility criteria.



If at any time, any information provided by the nominating organization is found to be incorrect in any manner, the nominating organization will be disqualified from the Awards process.



Certificate of incorporation is mandatory for all.

Award Categories

The awards are open to the following four distinct categories:



Category 1: Resource Efficiency & Circular Economy Innovations

Companies implementing circular business models, resource efficiency innovations or both, contributing towards environment sustainability, bridging resource availability gaps, fostering overall economic development and innovation etc.

For following industry segments:

Emerging | Evolving | Matured

(Applicants will be divided into industry segments basis: Revenue, Employee Headcount, Years of implementation of RECE practices & No. of worksites)



Category 2: Technology Disruptors

Entities developing technological solutions to support adoption of circular practices and resource efficiency more effectively.

2. Academia/ Research Institutions/ Regulatory bodies



Category 3: Collaboration and partnership for Impact

Companies/ with established collaboration & strategic partnerships working towards achieving the goal of circular economy and resource efficiency.

For:

1. Industries
2. Academia/ Research Institutions/ Regulatory bodies



Category 4: Renewable Materials Transition

Companies effectively transitioning towards renewable or alternate materials and innovating resource efficiency solutions with their value chain.
